ANNEXURE-I



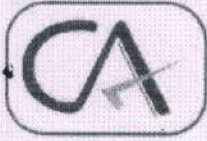

LIMITED REVIEW REPORT


